**4. GENERAL FIRM SALES SERVICE (GS-1)**

4.1. AVAILABILITY

4.1.1. This rate schedule is available to any individually metered, non-residential customer on Company's system who has experienced or anticipates experiencing an annual consumption of natural gas equal to or less than 5,000 Ccf. Service is not available under this rate schedule for resale to others or for standby service.

4.2. RATES

4.2.1. Each customer receiving service under this rate schedule shall be charged the sum of (a), (b), and (c) as follows:

(a) Monthly Customer Charge -- \$22.33

(b) Distribution Rate:

First 100 Ccf at \$0.5205 per Ccf

Over 100 Ccf at \$0.0975 per Ccf

(c) Gas Supply Rate - The Gas Supply Rate will be calculated and adjusted periodically as defined in the Company's Gas Supply Rate Rider.

In the event Customer was previously served pursuant to a transportation rider and subsequently elects to purchase all or a portion of its gas service requirements pursuant to this sales rate schedule, any remaining, unpaid telemetering costs owing to the Company are still due and payable, and the telemetering facilities and equipment shall remain in place.
