**1. RESIDENTIAL FIRM SALES SERVICE (RS-1)**

**1.1. AVAILABILITY**

1.1.1. This rate is available to any customer where gas is delivered to an individually metered, single, private dwelling and its appurtenances, the major use of which is for household appliances, and for the personal comfort and convenience of those persons residing therein. This rate schedule is not available for any dwelling used principally for commercial purposes. Natural gas supplied hereunder is for the individual use of the customer at the point of delivery and shall not be resold or shared with others. Standby service is not available under this rate schedule.

**1.2. RATES**

1.2.1. Each customer receiving service under this rate schedule shall be charged the sum of (a), (b), and (c) as follows:

(a) Monthly Customer Charge -- \$13.00

(b) Distribution Rate:

First 10 Ccf at \$0.5171 per Ccf  
Over 10 Ccf at \$0.1577 per Ccf

(c) Gas Supply Rate - The Gas Supply Rate will be calculated and adjusted periodically as defined in the Company's Gas Supply Rate Rider.
